The proposed works will include the following:

- Construct new Facility Centre for Water Based Activities
- Construct new public realm area adjacent to the facility
- Demolish existing Public Toilet Block
- Provide traffic calming measures and new pedestrian crossing on R558
- Provide two fully accessible car parking spaces
- Relocation of some play equipment within existing playground
- Provide temporary Public Toilet facilities for use during the construction stage

Kerry County Council as the Competent Authority has concluded that the proposed project, individually, and in combination with other plans and projects, is not one which requires an Appropriate Assessment (AA) or an Environmental Impact Assessment (EIA) and is not likely to have significant effects on the environment.
