### PLANNING & DEVELOPMENT ACT 2000 (AS AMENDED) NOTICE OF DRAFT DIRECTION BY THE MINISTER OF STATE FOR LOCAL GOVERNMENT AND PLANNING TO KERRY COUNTY COUNCIL AS REGARDS THE MAKING OF THE KENMARE MUNICIPAL DISTRICT LOCAL AREA PLAN 2024-2030

Notice is hereby given that on 23rd May 2024, Kerry County Council received notification from the Minister of State for Local Government and Planning of his intention to issue a Direction pursuant to Section 31 of the Planning and Development Act 2000 (as amended).

The Draft Ministerial Direction related to the adoption of the Kenmare Municipal District Local Area Plan 2024-2030.

#### The Planning Authority is directed to take the following steps:

Delete the following material alterations from the adopted Local Area Plan such that the subject lands revert to as indicated in the Draft Local Area Plan:

- Material Alteration 35 (Site KG-102) – i.e. the subject lands (located at Reen, Killorglin) revert to not zoned, from R1 New/Proposed Residential;
- Material Alteration 36 (Site KG-104) – i.e. the subject lands (located at Dromavalla, Killorglin) revert to not zoned, from M1 Mixed;
- Material Alteration 38 (Site KG-103) – i.e. the subject lands (located at Laharan, Killorglin) revert to not zoned, from R1 New/Proposed Residential;
- Material Alteration 18 (Site CH-103) – i.e. the subject lands (located at Garranearagh, Cahersiveen) revert to not zoned, from R4 Strategic Residential Reserve; and
- Material Alteration 60 – i.e. the subject lands (located at Tullig More, Killorglin) revert to not zoned, from C2.1 Industrial/Enterprise/Employment.

#### Reasons stated by the Minister for the Draft Direction:

I. The Local Area Plan as made includes material alterations to the draft Local Area Plan, which zone additional R1 New/Proposed Residential land in Killorglin inconsistent with the core strategy of the Kerry County Development Plan 2022-2028, and additional R4 Strategic Residential Reserve in Cahersiveen. These material alterations are located in peripheral and/or non-sequential locations, and/or unserved locations, and/or outside the CSO boundary of Cahersiveen. The material alterations would individually and cumulatively encourage a pattern of development in particular locations which is inconsistent with Objective KCDP 4-1 of the Kerry County Development Plan 2022-2028 and RPO 35 of the RSES to implement compact growth, Objective KCDP 3-6 to zone land for residential purposes in accordance with the tiered approach to zoning, and the policy for sequential zoning (section 6.2.3) under the Kerry County Development Plan 2022-2028, and the planning authority have provided no or no adequate reasons for not applying the policy and objective for sequential zoning contained in the Development Plans Guidelines for Planning Authorities (2022) issued by the Minister under section 28 of the Act.

II. The Local Area Plan as made includes a material alteration to the draft Local Area Plan, which zones additional M1 Mixed Use / Opportunity Site in Killorglin. This material alteration is located a peripheral location, remote from the existing town centre of Killorglin and partly outside the CSO boundary. This material alteration would encourage a pattern of development that is inconsistent with the implementation of Objective KCDP 4-61 of the Kerry County Development Plan 2022-2028 to ensure sustainable development by directing new retail opportunities into town centres and consolidating, intensifying, and enhancing existing core retail areas, and RPO 151 of the RSES for the integration of land use and transportation and optimising sustainable travel integration within settlements.

III. The Local Area Plan as made includes a material alteration to the draft Local Area Plan, which zones additional C2.1 Industrial / Enterprise / Employment land in an unserved, remote location, outside the CSO boundary and LAP settlement boundary for Killorglin, and on the N70 national road where the maximum speed limit applies, and where the lands are partially located within flood zone A and B. The material alteration would encourage a pattern of development in a location which does not meet the criteria for designating employment zonings under section 9.6.1 of the Kerry County Development Plan 2022-2028 (including NPO 72 of the National Planning Framework), and inconsistent with RPO 151 of the RSES for the integration of land use and transportation and optimising public transport and sustainable travel integration within settlements, Objective KCDP 9-22, Objective KCDP 14-29, and Objective KCDP 14-30 of the Kerry County Development Plan 2022-2028 to protect the capacity and safety of national roads in compliance with the Spatial Planning and National Roads Guidelines (2012) and does not apply section 2.5 of these guidelines, and RPO 116 of the RSES to avoid inappropriate development in areas at risk of flooding in accordance with The Planning System and Flood Risk Management Guidelines for Planning Authorities (2009), and does not apply these guidelines.

IV. The Local Area Plan has not been made in a manner consistent with, and has failed to implement, the recommendations of the Office of the Planning Regulator under section 31AO of the Act.

V. In light of the matters set out at I to III above, the Minister is of the opinion that the Local Area Plan as made is inconsistent with the objectives of the Development Plan of the area, which is a requirement of section 19(2) of the Act.

VI. The Local Area Plan as made is not consistent with the objectives of the RSES contrary to section 19(2) and section 27(1) of the Act.

VII. The Minister is of the opinion that the Local Area Plan as made is not consistent with National Policy Objectives 33 and 57 of the National Planning Framework.

VIII. The Minister is of the opinion that the Local Area Plan as made fails to set out an overall strategy for the proper planning and sustainable development of the area.

IX. The Local Area Plan is not in compliance with the requirements of the Act.

Tugtar fógra leis sin, ar an 23 Bealtaine 2024, go bhfuair Comhairle Contae Chiarraí fógra ón Aire Stáit don Rialtas Áitiúil agus Pleanáil, ag cur in iúl go bhfuil sé beartaithe aige Ordachán a eisiúint de bhua Alt 31 d'Acht um Pleanáil agus Forbairt, 2000 (arna leasú).

Bhain an Dréacht-Ordachán ón Aire le glacadh le Plean Ceantair Áitiúil Cheantar Bardasach Neidín 2024-2030.

#### Treoraítear don Údarás Pleanála na céimeanna seo a leanas a chur i gcrích:

Na hathruithe ábhartha seo a leanas a scriosadh ón bPlean Ceantair Áitiúil ionas go mbeidh na tailte ábhartha ag teacht leis an méid atá sonraite sa Dréachtphlean Ceantair Áitiúil:

- Athru Ábhartha 35 (Láithreán KG-102) – i.e. na tailte ábhartha (lonnaithe ag An Rinn, Cill Orglan) le hathrú ar ais go dtí tailte neamhchriosaithe, ó R1 Forbairt Chónaithe Nua/Bheartaithe;
- Athru Ábhartha 36 (Láithreán KG-104) – i.e. na tailte ábhartha (lonnaithe ag Drom an Bhaile, Cill Orglan) le hathrú ar ais go dtí neamhchriosaithe, ó M1 Measctha;
- Athru Ábhartha 38 (Láithreán KG-103) – i.e. na tailte ábhartha (lonnaithe ag An Leathfhearn, Cill Orglan) le hathrú ar ais go dtí neamhchriosaithe, ó R1 Forbairt Chónaithe Nua/Bheartaithe;

Cuirtear sa Plean Ceantair Áitiúil ama dhéanamh athruithe ábhartha ar an Dréachtphlean Ceantair Áitiúil, a chriosáonn talamh breise R1 Forbairt Chónaithe Nua/Bheartaithe i gCill Orglan atá ar neamhréir le croistraitéis Phean Forbartha Contae Chiarraí 2022-2028, agus R4 Cúltaca Straitéiseach Cónaithe i gCathair Saibhbhín. Tá na hathruithe ábhartha seo lonnaithe i suíomhanna imeallacha agus/nó neamhsheicheamhacha, agus/nó suíomhanna neamhsheirbhíthe, agus/nó lasmuigh de theorainn CSO Chathair Saibhbhín. Spreagadh na hathruithe ábhartha, ina n-aonar agus le chéile, patrún d'fhorbairt ag suíomhanna áirithe atá ar neamhréir le Cuspóir PFCC 4-1 de Phean Forbartha Contae Chiarraí 2022-28 agus CPR 35 de SRSG chun dlúthfás a chur chun feidhme, Cuspóir PFCC 3-6 chun talamh a chriosú chun críocha cónaithe de réir an chuir chuide straitéiseach maidir le criosú, agus an beartas maidir le criosú seicheamhach (rannóg 6.2.3) faoi Phean Forbartha Contae Chiarraí 2022-2028, agus nior sholáthair an t-údarás pleanála aon chúis leordhóthanach ná aon chúiseanna leordhóthanacha don chinneadh gan an beartas agus an cuspóir do chriosú seicheamhach atá le fáil sna Treoirínte maidir le Pleananna Forbartha d'Údarás Pheanála (2022) eisthe ag an Aire faoi alt 28 den Acht a chur i bhfeidhm.

II. San áireamh sa Phean Ceantair Áitiúil ama dhéanamh tá athru ábhartha ar an Dréachtphlean Ceantair Áitiúil, a chriosáonn M1 Usáid Mheasctha / Láithreán Deise breise i gCill Orglan. Tá an t-athru ábhartha seo lonnaithe i suíomh imeallach, scoite ó lár baile Chill Orglan faoi láthair agus tá cuid den athru seo lasmuigh de theorainn CSO. Spreagadh an t-athru ábhartha seo patrún forbartha atá ar neamhréir le cur chun feidhme Cuspóir PFCC 4-1 de Phean Forbartha Contae Chiarraí 2022-2028 chun forbairt inbhuanaithe a chinntiú trí dheiseanna miondíola nua a threorú i dtreo lár baile agus trí chroílínistéir mhiondíola atá forbartha cheana féin a chomhdhlúthú, a neartú agus a fheabhsú, agus CPR 151 de SRSG chun talamhúsáid agus iompar a chomhtháthú agus chun comhtháthú taistil inbhuanaithe a bharrfheabhsú laistigh de lonnaithe.

III. Cuirtear sa Phean Ceantair Áitiúil ama dhéanamh athru ábhartha ar an Dréachtphlean Ceantair Áitiúil ina gcríosaitear talamh breise C2.1 Forbairt Thionsclaíoch / Fiontraíochta / Fostaíochta i suíomh neamhsheirbhíthe, iargúla, lasmuigh de theorainn CSO agus de theorainn lonnaithe CPA do Chill Orglan, agus ar bhóthar náisiúnta an N70 atá a bhfuil an uas-luasteorainn i bhfeidhm, agus áit a bhfuil cuid de na tailte lonnaithe laistigh de chrios tuilte A agus B. Spreagadh an t-athru ábhartha seo patrún lonnaithe i suíomh nach bhfuil na critéir a bhaineann le hainmniú chriosanna fostaíochta faoi rannóg 9.6.1 de Phean Forbartha Contae Chiarraí 2022-2028 (lena n-áirítear CPN 72 den Chreat Náisiúnta Pleanála) á chomhlíonadh aige, agus atá ar neamhréir le CPR 151 de SRSG chomh fada is a bhaineann le comhtháthú talamhúsáide agus iompar agus comhtháthú iompar phoiblí agus taistil inbhuanaithe laistigh de lonnaithe a bharrfheabhsú, Cuspóir PFCC 9-22, Cuspóir PFCC 14-29 agus Cuspóir PFCC 14-30 de Phean Forbartha Contae Chiarraí 2022-2028 chun comhtháthú agus sábháilteacht bóithre náisiúnta a chosaint de réir na dTreoirínte maidir le Pleanáil Spásúil agus Bóithre Náisiúnta (2012) agus ní chuirtear i bhfeidhm rannóg 2.5 de na treoirínte seo, agus CPR 116 de SRSG chun forbairt mhíchui a sheachaint i gceantair lena mbaineann riosca tuilte de réir an Chórais Pleanála agus Bainistíochta Riosca i gcás Tuilte – Treoirínte d'Údarás Pheanála (2009), agus ní chuirtear na treoirínte seo i bhfeidhm.

IV. Ní dheamadh an Plean Ceantair Áitiúil ar bhealach atá ar comhréir le, agus theip air, moltaí Oifig an Rialála Pleanála faoi alt 31AO den Acht a chur chun feidhme.

V. I bhfianaise na nithe ama leagan amach idir I agus III thuas, tá an tAire den tuairim go bhfuil an Plean Ceantair Áitiúil ama dhéanamh ar neamhréir le cuspóirí an Phean Forbartha don cheantar, ar ionann é agus ceanglas d'alt 19(2) den Acht.

VI. Níl an Plean Ceantair Áitiúil ama dhéanamh ar comhréir le cuspóirí SRSG contrártha d'alt 19(2) agus d'alt 27(1) den Acht.

VII. Tá an tAire den tuairim nach bhfuil an Plean Ceantair Áitiúil ama dhéanamh ar comhréir le Cuspóir Bheartais Náisiúnta 33 agus 57 den Chreat Náisiúnta Pleanála.

VIII. Tá an tAire den tuairim go dteipann ar an bPlean Ceantair Áitiúil ama dhéanamh straitéis fhoriomlán a leagan amach do pleanáil chuí agus d'fhorbairt inbhuanaithe an cheantair.

IX. Níl ceanglas an Achte á gcomhlíonadh ag an bPlean Ceantair Áitiúil.
